2020 Tax and Fee Structure To Take Effect January 1st, 2020

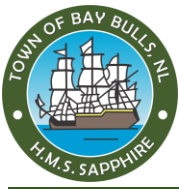

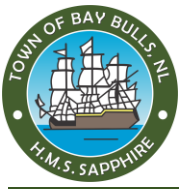
